The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Osmund (Bud) Jermeland, and Gary Rayhons present. Absent: none.

The minutes of May 27, 2025 were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Jermeland and carried unanimously, the Board gave approval to the following: Signed corrected quit claim deeds for vacation of 200<sup>th</sup> Street East of Echo Avenue in the West Half (W ½) of the Southwest Quarter (SW ¼) of section 11 of Boone Township to Jane Anderson and the Northwest Quarter (NW ¼) of the Northwest Quarter (NW ¼) of section 14 of Boone Township to Doris & Earl Schulz with Residuary Trust. Five-day special class C retail alcohol license for Nicole Schneider doing business as Nik's Tipsy Trailers beginning June 20, 2025.
